A letter from Richard L. Stewart, Principal

There is an appointed time for everything, and a time for every affair under heaven... a time to tear down, and a time to build up. - Ecclesiastes 3:1, 3

Each day here at Bishop Brossart it is our task to build up. We build, we hope, a firm and strong foundation for our students, a foundation rooted in the Gospel of Christ, a foundation of faith, of charity, of wisdom, of knowledge, and of discipline. We build a foundation on which our students will construct the edifice of their lives. That edifice may be one of simplicity and grace, or of grand magnificence, but it will be the foundation we build with them now which will give it permanence and strength.

But our school also needs to be built up, to be given a strong foundation from which it, from which we, may work. And for that foundation we must turn to you. It is a simple reality that financially we can not function merely on the basis of our student tuition. To do so would require that we raise tuition to a potentially prohibitive level. And so we turn to our community, a community that knows so well the value of a Bishop Brossart education. We ask you to build us up, to help us achieve that financial foundation that allows us to continue to build the edifice of a wonderful, life-giving, and life-transforming educational institution.

I ask in particular this year that you help us build this Annual Appeal. We can no longer afford for the goal of our Annual Appeal to remain a static amount. The unfortunate truth is that if we raise only the same amount that we raised last year, we in fact raise less, as each of those dollars buys less than it did the previous year. I know that economic times are difficult, and asking you to give more is asking a real sacrifice. But I remind you of the benefactors of that sacrifice: our kids. We owe our children all that we can give them, so I ask of you that you give all that you can.

If at all possible, consider raising your donation amount from last year. Building this Appeal is an important first step for us in building our school, in helping us build that firm foundation for our kids, and in helping them to build lives of grace and blessing for us all.

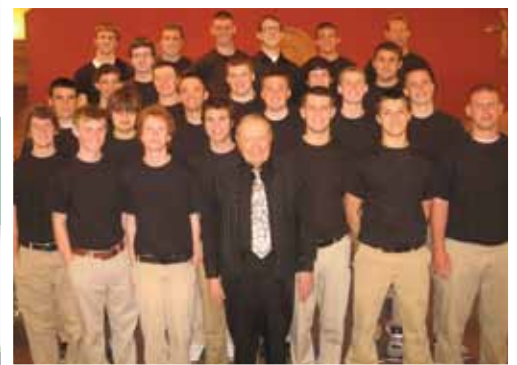
